

WIRE Deposit Licence

The University of Wolverhampton supports the principles of long-term preservation and open access for research outputs produced by members of the University. Research outputs are therefore stored and made publicly available via the institutional repository, WIRE, managed by the University Library.

In order for WIRE to preserve, reproduce, translate and distribute your submission worldwide, your agreement to this deposit licence is necessary.

By submitting your research outputs to WIRE you indicate that you agree to the terms of this non-exclusive licence.

Non Exclusive Distribution Licence Terms

By agreeing to this deposit licence, you will be granting a non-exclusive licence to the University of Wolverhampton (via WIRE or its successors).

The licence is non-exclusive, and therefore does not prevent you exercising any rights you might have to publish the material, in present or future versions, elsewhere.

This deposit licence agreement will also confirm that you, the depositor, have the right to submit the output to the repository.

Depositor declaration

By agreeing to this license, I (the author(s) or copyright owner) grant to the University of Wolverhampton Institutional Repository and E-Theses service (WIRE) the non-exclusive right to reproduce, translate and/or distribute my output (including the abstract) worldwide in print and electronic format and in any medium, including but not limited to audio or video.
